“Innovation and disruption remain fundamental forces of change in almost every area of business and society and are certainly a key consideration in today’s and future M&A and PE transactions.”

Following a strong year for M&A in 2018, in which IMAP closed 208 transactions worth over \$10.bn, and with the promise of a coordinated global growth scenario, the prognosis for 2019 was more of the same. However, 1Q 2019 saw the peak of the global growth story and since then there has been what seems to be a cyclical slowing of GDP growth worldwide, especially in industrial and manufacturing sectors. Ongoing trade war rhetoric, tensions within the EU, including an unresolved Brexit situation, and other geopolitical tensions obviously do not enhance the deal-making environment.

Despite this, IMAP began the year with the same momentum as it saw in 2018 and closed more deals in 1H 2019 than in the same period in 2018, with 102 M&A transactions worth over \$3.5bn. The strongest out of the 15 sectors covered by IMAP were Technology, Consumer & Retail and Healthcare, which together accounted for 46% of the total deals closed.

In 2019, we have further strengthened IMAP's international footprint, with the addition of 2 new partners. In January, we welcomed Degroof Petercam Investment Banking (DPIB), as our exclusive partner in Belgium and France and co-partner in Spain. This is a major development for IMAP, one which will

make a significant advance in the presence and image of IMAP in these major European markets. In March, we were then joined by Invest Corporate Finance, our exclusive partner in Portugal. A strong addition to our Iberian team, they will play a pivotal role as a conduit for Portuguese investments throughout Europe and the world.

This year, we also announced the launch of IMAP China, an international team that specializes in mid-market Chinese outbound M&A transactions, another step in our strategy to better service our IMAP partners and adapt quickly to changes in the Chinese market.

Following a strong 2019 to date, we remain optimistic about deal activity going forward. Horizontal industry consolidation, succession, international expansion, growth strategy execution and PE exits continue to drive M&A activity. Innovation and disruption remain fundamental forces of change in almost every area of business and society and are certainly a key consideration in today's and future M&A and PE transactions. As mentioned last year, we are living in one of the most exciting periods of change in human history and at IMAP, I am proud to say, we have just the right team and energy to guide our clients through the turbulent times ahead.

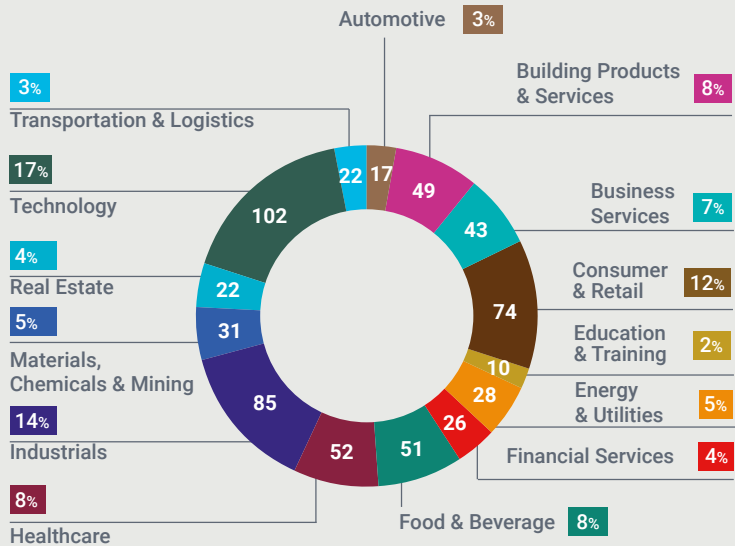

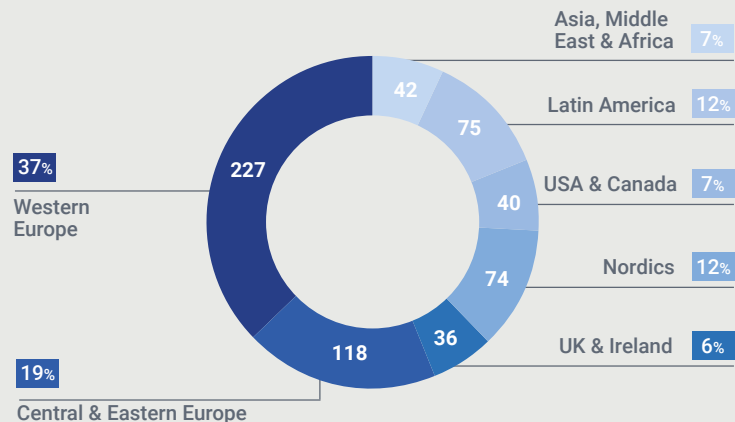

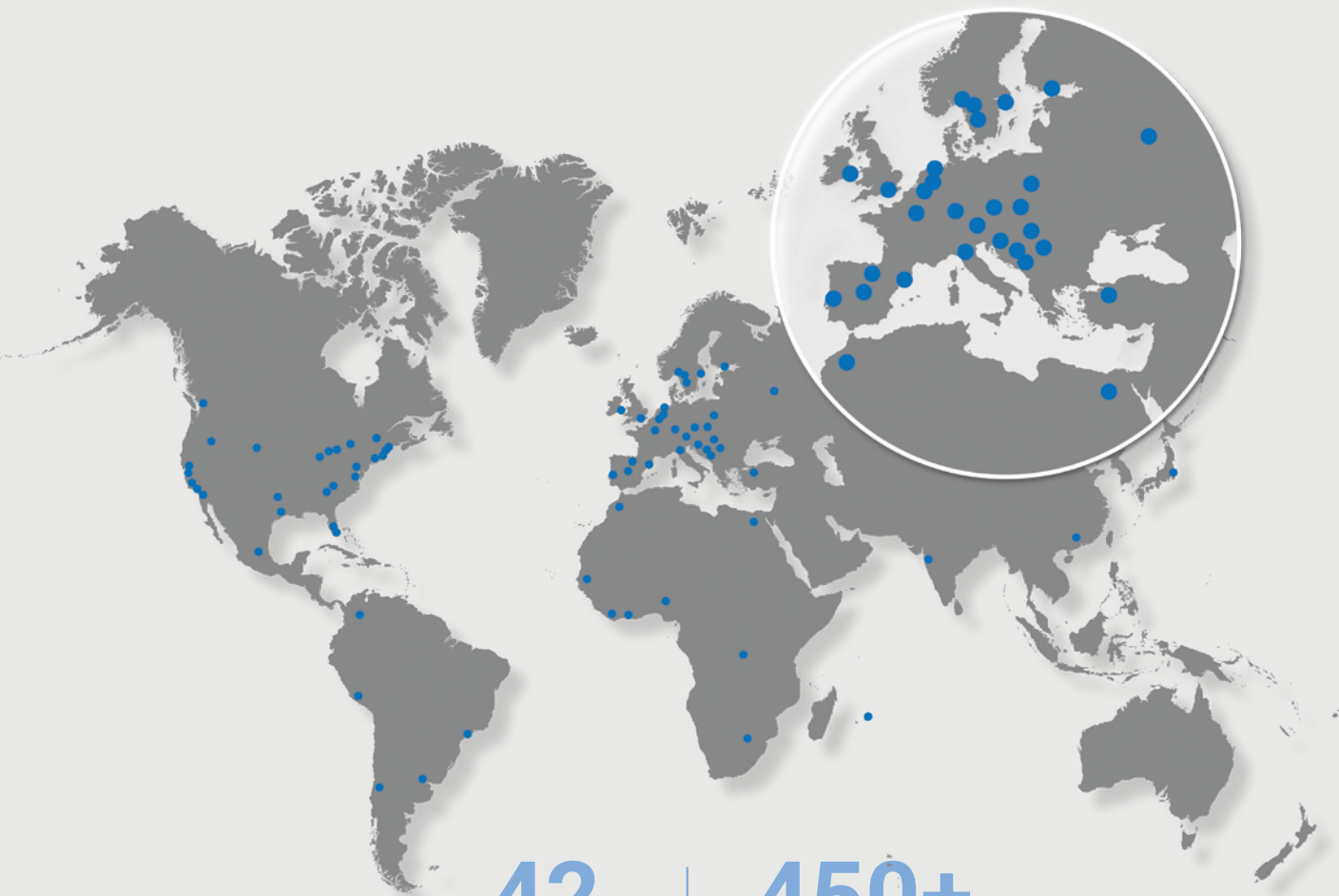
DEALS BY SECTOR 2016-2018
